A RESOLUTION OF THE BOARD OF COMMISSIONERS
OF SOUTHWEST SUBURBAN SEWER DISTRICT, KING
COUNTY, WASHINGTON, RATIFYING AND CONFIRMING
ACCEPTANCE, AS COMPLETED, THE CONTRACT
COMMONLY KNOWN AS THE DISTRICT SMALL WORKS ROAD REPAIR
PROJECT, BETWEEN SUPERIOR ASPHALT, INC.
AS CONTRACTOR, AND SOUTHWEST SUBURBAN SEWER
DISTRICT, AS OWNER

WHEREAS, the District entered into a contract known as the District Small Works Road Failure project ("Contract") with Superior Asphalt, Inc., for the repair of two separate road failures located at: Site #1 1029 SW 124th ST and Site #2 10046 15th Ave SW; and

WHEREAS, the District has certified that the contractor has completed the contract and recommend acceptance of the project as complete; and

WHEREAS, Southwest's Board of Commissioners accepted such contract as complete in its regular meeting held on July 5, 2016; and

WHEREAS, the District determined that a cost of construction amount be paid to Superior Asphalt, Inc. of \$23,576.00 w/o sales tax, includes additional construction costs in the amount of \$2,376. The original contract amount was established at \$21,200.00 w/o tax. Total cost of project, including sales tax, totaled \$25,839.30.

WHEREAS, it was determined that the Retainage in the amount of \$1,178.80, shall be released upon receiving the following information:

- a) Verification that no liens have been filed against this public work improvement for thirty (30) days from the date of completion of the contract work; and
- b) On completion of (a), then said retainage may be released by the District on or after thirty (30) days from the date of completion of the contract work.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Southwest Suburban Sewer District, King County, Washington, as follows: Prior action accepting as complete the Contract commonly known as the Road Repair Project on July 5,2016, is ratified and confirmed. There is retainage in the amount of \$1,178.80, which is still due to be released to the contractor. The retainage shall be held and released to the contractor on or after thirty (30) days from the date of contract acceptance (June 23, 2016) as ratified by this resolution, provided

that, prior to release of such retainage, that no liens have been filed against the retainage within 30 days from the completion of contract work, or that any such claims or liens have been satisfied by the contractor within such thirty (30) days period.
