WHEREAS, Southwest Suburban Sewer District has entered into a Developer Extension Agreement with the following described Developer (A), and the Developer Extension was completed on the following date (B):

- A. Greenbridge 8 #233 – By King County Housing Authority
- B. November 16, 2021

Project Description: Mainline extension to serve future developments.

Bill of Sale Assets: 236-feet of 8” main, 126-feet of 6” stub, 3-48” manholes.

WHEREAS, the contributions in aid of construction have been recorded in the Bill of Sale in the amount of \$73,225.00.

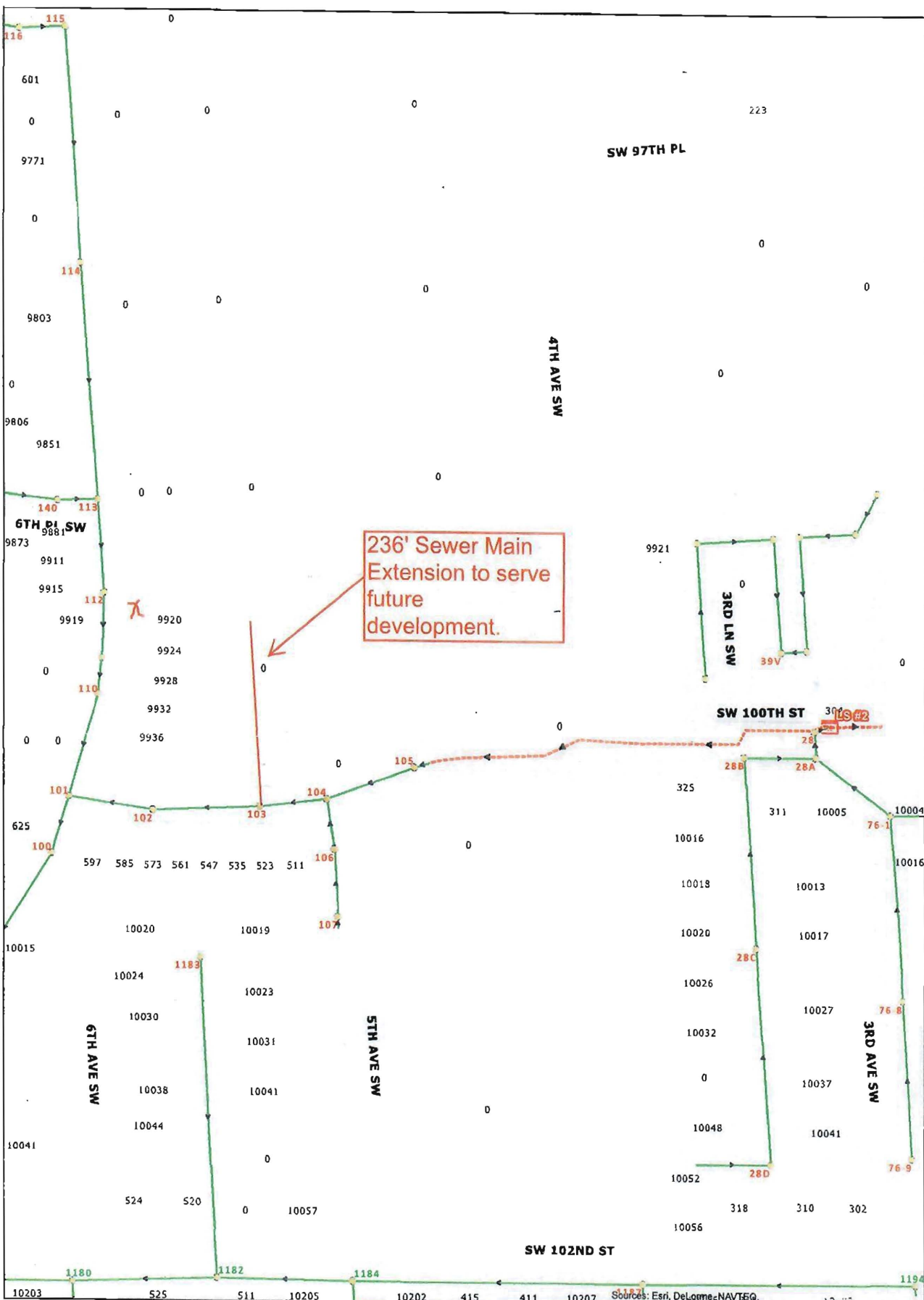

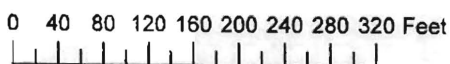
