# IMPORTANT INFORMATION ON BACK

During the past year your sewer dollars have been at work catching up on preventative maintenance throughout the District. In addition, the first of many necessary line replacement projects is underway.

A number of projects were budgeted in 2005. They include:

- Completion of the Rehabilitation of Pump Station
  #7—\$250,000
- Installed a pipe liner in a pipe on 1st Avenue So.— \$30,000

- Smoke tested 20,000 lineal feet of sewer mains.
- Cleaned the digesters at Miller Creek Treatment Plant and installed new covers—\$250,000
- Replaced the boiler at Miller Creek Treatment Plant—\$40,000
- Replaced the roof on the primary clarifiers at Miller Creek Plant—\$40,000
- Nearing completion on a \$2,000,000 pipe rehabilitation project in the North Highline area.

- Replaced 20 year old sewer cleaning and inspection equipment to improve efficiency, identify problems and extend the life of existing lines.
- Installed a variety of power conservation projects replacing 20 year old equipment with energy efficient motors and controls.

The majority of the sewer system is over 50 years old and in need of major repair or replacement. More projects are budgeted for 2006 and future years.

### **2006 RATES**

Last year the Board of Commissioners spent a great deal of time working on the budget with the Citizens Advisory Committee, identifying methods of paying for needed repairs and replacements. The Citizens Advisory Committee recommended raising rates from \$13.50 to \$21 per month. The Board decided to phase in the rate increase over five years. The strategy was discussed at the public Rate Hearing held December 14th, Rates were raised to \$17.50 on January 1, 2005.

At the regular Board Meeting held November 8th, 2005, the Board of Commissioners approved a rate increase of \$2.00 per month. Effective January 1, 2006, the new rate will be \$19.50 per month. The District's rates will still be the second lowest in King County and just over 50% of the average King County sewer bill. A rate comparison chart is provided on the back of this newsletter comparing rates through the current year.

The Board of Commissioners will continue to look for low interest loans and grants, however the bulk of the repair and replacement costs of the aging sewer system will be paid with rates.

STREET LIGHTS: During the past year, City Light performed a street light audit and discovered that the District was not paying for a number of street lights that were our responsibility. In addition, the City of Burien requested the District accept responsibility for arterial lighting that King County is no longer paying. During 2005, the street lighting costs exceeded street light revenues by \$1,000 per month. After reviewing the costs related to street lighting, the Board of Commissioners raised rates from \$.85 per month to \$1.10 per month.
