**A RESOLUTION OF THE BOARD OF COMMISSIONERS OF

THE FOLLOWING DESCRIBED DEVELOPER EXTENSION**

WHEREAS, Southwest Suburban Sewer District has entered into a Developer Extension Agreement with the following described Developer, and the Developer Extension has been inspected and is considered to be substantially completed on the following date:

- A. Greenbridge Phase V, Developer Extension
Substantially Completed on July 12, 2011.

WHEREAS, the staff has determined that the Developer Extension is substantially completed and has met the terms and conditions of the contract to date, and,

WHEREAS, the contributions in aid of construction have been recorded in the Bill of Sale to Southwest Suburban Sewer District totaling \$111,499.00.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Southwest Suburban Sewer District, King County, Washington, as follows:

1. The Developer Extension and improvements as described herein are accepted by the District, and the District's staff is directed to adjust the Comprehensive Plan to reflect the addition of the improvements.
2. The District's staff is directed to take the necessary steps to conclude the Developer Extension Agreement.
