## RESOLUTION 2012-01

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF SOUTHWEST SUBURBAN SEWER DISTRICT, KING COUNTY, WASHINGTON, RATIFYING AND CONFIRMING AS COMPLETED, THE CONTRACT COMMONLY KNOWN AS THE CHELSEA PARK VI PROJECT, BETWEEN RODARTE CONSTRUCTION, AS CONTRACTOR, AND SOUTHWEST SUBURBAN SEWER DISTRICT, AS OWNER

WHEEAS, the District entered into a contract known as the Chelsea Park Phase VI Project ("Contract") with Rodarte Construction, for the installation and repair of sewer infrastructure; and

WHEREAS, the District has certified that the contractor has completed the contract and recommend acceptance of the project as complete; and

WHEREAS, Southwest's Board of Commissioners, for purposes of the Public Works Trust Fund Loan, accepted such contract as substantially completed in its regular meeting held on July 26, 2011; and

WHEREAS, the District has received releases from the Department of Labor and Industries, the Department of Revenue and the Employment Securities Department, and has certified no liens have been filed against the contractor's retainage bond, and

WHEREAS, the District determined that there was a total amount paid to Rodarte Construction, of \$699,593.21 representing the original contract amount of \$621,996.00 and bid item additions and deletions previously authorized in the amount of \$16,901.91 which, including sales tax of \$60,695.30, totaled \$699,593.21; and of such sums \$699,593.21 was paid to Rodarte Construction, by the District; and

WHEREAS, it is determined that a Retainage Bond in the amount of \$34,054.28 shall be released to the bonding agency, upon confirming action taken under this resolution.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Southwest Suburban Sewer District, King County, Washington, as follows: Prior action accepting as complete the Contract commonly known as the Chelsea Park Phase VI Project on January 3, 2012, is ratified and confirmed. There is a retainage bond which is still due to be released to the contractor. The retainage bond shall now be released to the contractor from the date of final contract acceptance (January 3, 2012) as ratified by this resolution.
