## RESOLUTION NO. 2012-03

A RESOLUTION OF THE SOUTHWEST SUBURBAN SEWER DISTRICT, KING COUNTY, WASHINGTON, ADOPTING NEW FEES, AND AMENDING PREVIOUS RESOLUTIONS.

WHEREAS, pursuant to RCW 57.08.005(3), the Southwest Suburban Sewer District ("District") has full authority to regulate and control the use, content, distribution and price of sewer services provided by the District to its customers; and

WHEREAS, RCW 57.08.081 authorizes the District to fix rates and charges for furnishing sewer service and facilities to those to whom sewer service is available and for providing such service, such rates and charges to be fixed as deemed necessary by the District Board of Commissioners so that uniform charges will be made for the same class of customer or service and facility; and

WHEREAS, after considering the recommendations of the District staff, by a motion duly adopted at a regular Board meeting on February 21, 2012, the District Board of Commissioners determined that an increase of certain fees effective March 1, 2012 was necessary to cover actual business expenses and was in the best interest of the District, and the Board directed that a formal resolution reflecting the increased fees be prepared for approval by the Board, now therefore

BE IT RESOLVED by the Board of Commissioners of Southwest Suburban Sewer District, King County, Washington, that the fees set forth in **Exhibit A** attached hereto and incorporated herein by this reference are hereby adopted and shall be in effect as of March 1, 2012.

IT IS FURTHER RESOLVED that all District resolutions, policies and procedures are hereby amended to be in accordance with this Resolution.
