

# RESOLUTION NO. 2012-13

## A RESOLUTION OF THE BOARD OF COMMISSIONERS OF SOUTHWEST SUBURBAN SEWER DISTRICT, KING COUNTY, WASHINGTON, AUTHORIZING THE TRANSFER OF FUNDS FROM THE MAINTENANCE FUND TO THE CONSTRUCTION REVOLVING FUND

**WHEREAS**, Resolution 90-2 established the Construction Revolving Fund for the purpose of financing capital improvement and debt service, and

**WHEREAS**, Resolution 90-2 required that all connection charges; installment payments, plus interest; and a portion of the service charges be transferred to the Construction Revolving Fund on an annual basis; and

**WHEREAS**, the Board of Commissioners determined that a minimum of \$1,500,000.00 each year should be transferred from the Maintenance Fund to the Construction Revolving Fund, and

**WHEREAS**, there are future capital facilities that require funding; and

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of Southwest Suburban Sewer District, King County, Washington, as follows:

1. The General Manager is authorized and directed to transfer the sum of \$ 1,500,000.00 from the Maintenance Fund Account # 11-555-0010 to the Construction Revolving Fund, Account # 11-555-3020 for the purpose of funding the District's capital facilities and satisfying debt.


