RESOLUTION NO. 2013-03

A RESOLUTION OF SOUTHWEST SUBURBAN SEWER DISTRICT, KING COUNTY, WASHINGTON, RELATING TO A TRANSFER OF A PORTION OF SOUTHWEST SUBURBAN SEWER DISTRICT TO MIDWAY SEWER DISTRICT PURSUANT TO RCW 57.32.160.

WHEREAS, Southwest Suburban Sewer District ("SWSSD") and Midway Sewer District ("Midway") are special purpose municipal corporations that provide sewer services to residents and customers within their respective service areas; and

WHEREAS, pursuant to RCW 57.32.160, the Legislature has authorized a transfer of property between adjacent water-sewer districts provided that the owners of not less than sixty percent (60%) of the area of land to be transferred have signed a petition requesting the transfer and the property to be transferred can be better served by the district to receive the additional property; and

WHEREAS, SWSSD and Midway have received petitions signed by the owners of certain real property constituting not less than sixty percent (60%) of the area of land to be transferred, true and correct copies of said petitions being attached hereto as **Exhibit A**; and

WHEREAS, the area of land to be transferred from SWSSD to Midway is legally described as follows:

The West 230 feet of the South Half of the Southwest Quarter of the Northeast Quarter of the Southwest Quarter of Section 32, Township 23 North, Ranger 4 East, W.M., in King County, Washington

(the "Subject Property");

WHEREAS, SWSSD's Board of Commissioners has reviewed the petitions and believing that the Subject Property can be better served by Midway, the Board of Commissioners of Southwest Suburban Sewer District approves of the petitions and desires that all steps be taken to formally transfer the Subject Property from SWSSD to Midway; now, therefore,

BE IT RESOLVED by the Board of Commissioners of Southwest Suburban Sewer District, King County, Washington, as follows:

Section 1: Approval of the Petitions. SWSSD, believing that the statutory requirements of RCW 57.32.160 have been duly satisfied, hereby approves of the petitions submitted by the property owners of the Subject Property.

Section 2: Approval of Petitions by Midway Sewer District. The petitions have been submitted to Midway Sewer District for its review, consideration and approval. On September 11, 2013, the Midway Board of Commissioners adopted Resolution No. 2013-13 approving of the petitions and authorizing the transfer of the Subject Property from SWSSD to Midway.

Section 3: Effectuating the Transfer of Subject Property. SWSSD hereby authorizes its staff, engineer and attorney to take all steps required by statute in order to effectuate the formal transfer of the Subject Property from Southwest Suburban Sewer District to Midway Sewer District, including any review by the Boundary Review Board that may be required under applicable law; provided that Midway shall be responsible for processing this transfer through the Boundary Review Board.
