A RESOLUTION OF THE BOARD OF COMMISSIONERS OF SOUTHWEST SUBURBAN SEWER DISTRICT, KING COUNTY, WASHINGTON, APPROVING AND RATIFYING THE PUBLIC WORKS TRUST FUND PRE-CONTRUCTION LOAN AGREEMENT RELATING TO THE SALMON CREEK SEWER BASIN REHABILITATION AND REPAIR PROJECTS.

WHEREAS, Southwest Suburban Sewer District ("District") is a special purpose watersewer district operating pursuant to Title 57 RCW and is authorized to provide sewer service to real property located within the District's service area and corporate boundaries; and

WHEREAS, the District has determined that it is necessary to engage in certain planning, engineering and permitting for Lift Station No. 17 rock catching manhole, Standring Lane pipe rehabilitation, Salmon Creek Treatment Plant trunk line rehabilitation, and Areas A and B rehabilitation (the "Project"); and

WHEREAS, the District applied to the Washington State Public Works Board ("PWB") for a Public Works Trust Fund pre-construction loan to pay for certain pre-construction activities relating to the Project, and the PWB approved a PWTF pre-construction loan to the District in the amount of \$566,500 at an interest rate of 0.86% per annum on the outstanding principal loan balance for a term of 5 years; and

WHEREAS, the PWB requires the District as a condition of receiving the loan funds to approve and sign the Preconstruction Loan Agreement Number PR24-96103-003 in the form attached hereto as Exhibit A and incorporated herein by this reference ("Loan Agreement"); now, therefore,

BE IT RESOLVED by the Board of Commissioners of Southwest Suburban Sewer District, King County, Washington, that the Loan Agreement is hereby approved, ratified and confirmed that Ronald Hall, the General Manager of the District, is/was hereby authorized and directed to sign the Loan Agreement and all related documents which may be required by the PWB on behalf of the District.
