Project Description: 6-Story building with 95 studio units.

Bill of Sale Assets: 39-Feet of 8-Inch DI, (1) 48-Inch Manhole.

WHEREAS, the contributions in aid of construction have been recorded in the Bill of Sale in the amount of \$102,385.00




