The Board received a letter from Mr. Bryan Hastings of Whitewater Aquatics Management requesting forgiveness of a late fee penalty of \$791.63 for the Evergreen Pool. After brief discussion, M/S/P unanimously approving the request.

After discussion, the Board indicated that it was supportive of the letter and authorized the General Manager to issue the letter to Seattle.
