

RESOLUTION 2010-06
**A RESOLUTION OF THE BOARD OF COMMISSIONERS
OF SOUTHWEST SUBURBAN SEWER DISTRICT, KING COUNTY,
WASHINGTON, ACCEPTING AS COMPLETE
THE 9TH AVE SW EXTENSION PROJECT
AND ESTABLISHING AN APPLICABLE
LOCAL FACILITY CONNECTION CHARGE**

WHEREAS, Southwest Suburban Sewer District entered into a contract with **Hoffman Construction**, for the installation of certain sewer facilities referred to herein as the **9th Ave SW District Extension** project; and

WHEREAS, the work performed by the contractor on the **9th Ave SW District Extension** project has been inspected by the District's staff and/or its representatives and the work has been determined to be complete as of **April 1, 2010**, and otherwise in compliance with the terms and conditions of the construction contract; and

WHEREAS, the costs incurred by the District in connection with the **9th Ave SW District Extension** project equal **\$33,766.00**; and

WHEREAS, the District desires to accept the **9th Ave SW District Extension** project as complete; and

WHEREAS, pursuant to RCW 57.08.005(10) the District desires to establish a local facility connection charge applicable to certain parcels of real property so that property owners who seek to connect to the District's sewer system in the future will pay an equitable, pro rata share of the cost of sewer facilities constructed as a part of the **9th Ave SW District Extension** project;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Southwest Suburban Sewer District, King County, Washington, as follows:

1. The sewer facilities constructed as a part of the **9th Ave SW District Extension** project are accepted by the District as complete and the District's staff is directed to update the District's records to reflect the addition of: **(1) 560 lineal feet 6" PVC sewer main and lateral stubs, (2) Four 6" Clean Outs were installed as a part of the 9th Ave SW District Extension.**

2. The District certifies that the costs incurred by the District in connection with the Bonnie Wood North District Extension project are as follows:

Hoffman Construction	\$ 32,799.00
Engineering and Surveying	\$ 500.00
District Inspection	\$ 467.00
TOTAL	\$ 33,766.00

3. The District has determined that the following parcels of real property located within the District's service area shall be required to pay, as a condition of connecting to the District's sewer system, a local facility connection charge as identified below which connection charge has been determined by the District to be an equitable pro rata share of the project costs incurred by the District in connection with the **9th Ave SW District Extension** project, plus interest as authorized by District policy and state law:

4. In addition to the local facility connection charge identified above, property owners seeking to connect to the District's sewer system shall pay such other connection charges, rates and fees as may be applicable under current District policy and state law.


The connection charges associated with such future connections will be determined in the future based on the allocated costs of the 9TH Ave SW District Extension project, plus such additional costs as may be incurred by the District in order to construct the remaining sewer facilities necessary to provide sewer service to these additional properties.
