A RESOLUTION OF THE BOARD OF COMMISSIONERS

ACCEPTANCE, AS SUBSTANTIALLYCOMPLETE, THE CONTRACT
COMMONLY KNOWN AS THE MILLER CREEK EMERGENCY SCREW PRESS
REPLACEMENT PROJECT, BETWEEN GENERAL MECHANICAL, INC.
AS CONTRACTOR, AND SOUTHWEST SUBURBAN SEWER
DISTRICT, AS OWNER

WHEREAS, the District entered into a contract known as the Miller Creek Emergency Screw Press Replacement Project ("Contract") with General Mechanical, Inc., for the emergency installation of an FKC Screw Press; and

WHEREAS, the District certifies that the contractor has substantially completed contract work and do recommend acceptance of the project as substantially complete; and

WHEREAS, Southwest's Board of Commissioners accepted such contract as substantially complete in its regular meeting held on May 31, 2016; and

WHEREAS, the District determined work complete to date at 95% of the total contract amount of \$92,504.00, without sales tax. With this resolution, total amount paid to General Mechanical, Inc. shall be \$87,878.40, representing 95% of the original contract amount, less state sales tax in the amount of \$8,393.94 and retainage in the amount of \$4,393.94; and

WHEREAS, it was determined that the Retainage and final payment be made at completion of all project work, and shall be released upon receiving the following information:

- a) Verification that no liens have been filed against this public work improvement for thirty (30) days from the date of completion of the contract work; and
- b) On completion of (a), then said retainage may be released by the District on or after thirty (30) days from the date of completion of the contract work.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Southwest Suburban Sewer District, King County, Washington, as follows: the Contract commonly known as the Miller Creek Emergency Screw Press Replacement Project as substantially complete on May 31, 2016, is ratified and confirmed.
