WHEREAS, the Board of Commissioners has determined the District will finance such construction at this time with the District's funds and without bond issuance.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Southwest Suburban Sewer District, King County, Washington, as follows:

 The General Manager is authorized and directed to transfer the sum of \$ 3,500,000.00 from the Construction Revolving Fund, Account # 11-555-3020 to the Construction Fund, Account # 11-555-3010 for the purpose of funding the District's share of the following improvements in the amounts as set forth in "Exhibit A" as attached.
