WHEREAS, The District has established the Construction Revolving Fund to accumulate sewer revenues, connection charges, assessments and other capital contributions for the purpose of financing necessary District capital improvements and debt service; and

WHEREAS, the District has undertaken certain other capital improvements as set forth below; and

WHEREAS, the Board of Commissioners has determined the District will finance such construction at this time with the District's funds and without bond issuance.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Southwest Suburban Sewer District, King County, Washington, as follows:

1. The General Manager is authorized and directed to transfer the sum of \$5,963,383.00 from the Maintenance Fund, Account #11-555-0010 to the Construction Revolving Fund, Account #11-555-3020 for the purpose of funding the District's capital improvement projects.

On January 7th, 2020 the District Board of Commissioners approved the updated Financial Management Policy and I am requesting the following transfer based on the approved policy and attached is the supporting document for the transfer.

1. Operating reserve:

Sewer- 60 days of O&M expenses

Based on the 2020 district adopted budget the total operating expense will be \$8,453,066 and 60 days of the annual O&M will be \$1,389,545

2. Capital reserve

2% of original asset value for the sewer

Based on the current District Trial Balance the total fixed asset is \$170,256,985 (See attached GL Trial Balance) and 2% will be \$3,405,140

3. Rate stabilization fund

Sewer- 10% of annual rate revenue

Based on the 2020 District budget approved the total annual rate revenue will be \$11,686,978 (See attached approved budget worksheet) and 10% will be \$1,168,698

4. Bond Reserve Fund

Based on the current bond schedule payment, the Principal and Interest due within one year will be \$\$2,201,965 and the current bond reserve balance is \$774,267 and as per the amended policy we need to transfer a total of \$1,427,697 to the District Bond Reserve account.

 - 1. A total of \$5,963,383 from Maintenance fund (115550010) to Construction Revolving Fund (115553020)
 - 2. A total of \$1,427,697 from Maintenance fund (115550010) to Bond Fund (115558040)
