Commercial.....	\$ 47.00 /month for 1 <sup>st</sup> 750 cubic feet (CF) water used, and \$ 6.00 /month per each 100 CF. beyond 1 <sup>st</sup> 750 CF.
Late Charge.....	10% fee charged for bill not paid in full be end of the month following the period shown.
NSF/Returned Cks...	\$ 20.00 per item
Lien Filing Fee.....	\$ 125.00
Duplicate Bill.....	\$0.50/month, billed bi-monthly - flat rate
